Subject: Participation of the Latvian delegation at the FISU Winter World University Games Changchun 2027 — legal restrictions under national legislation and request for clarification regarding entry deadlines

Dear President Eder,
Dear Members of the FISU Executive Committee,
Dear Organising Committee of Changchun 2027,

On behalf of the Latvian University Sports Federation (Latvijas Augstskolu Sporta Savienība, LASS), the national university sports federation of the Republic of Latvia and a long-standing member of FISU, we wish to express our sincere desire that Latvian student-athletes take part in the 33rd FISU Winter World University Games in Changchun, China, on 15–25 January 2027. Winter sports hold a special place in Latvian university sport, and our student-athletes have been preparing for these Games with great commitment.

At the same time, we must inform you, with regret, of a serious legal obstacle that currently prevents us from confirming our participation.

1. The legal situation in Latvia

Following the FISU Executive Committee decision of 26 May 2026, which reinstated student-athletes from Belarus under full national conditions and permits the participation of Russian student-athletes in at least a neutral capacity, a direct conflict has arisen with the national legislation of the Republic of Latvia.

The Sports Law of the Republic of Latvia currently prohibits Latvian athletes from taking part in international sports competitions together with athletes representing aggressor states, namely the Russian Federation and the Republic of Belarus. The position of the Ministry of Education and Science of the Republic of Latvia, which oversees the field of sport, is unambiguous: *“The Sports Law currently prohibits participation together with aggressor states.”*

This means that, as the law stands today, LASS is legally not permitted to enter a delegation in an event in which athletes from the Russian Federation and/or the Republic of Belarus will compete, irrespective of whether they compete under a neutral or a national status. This is not a decision of our Federation, nor a reflection of our attitude towards FISU or the host country; it is a binding requirement of national law which we are obliged to respect.

2. Requests for information and clarification

In order to allow our Federation, the Ministry of Education and Science and the Government of Latvia to fully assess the situation, we kindly ask FISU and the Organising Committee to clarify the following:

1. Whether, and under what status (neutral or national), student-athletes from the Russian Federation and the Republic of Belarus are expected to participate at Changchun 2027, both overall and per individual sport, taking into account the positions of the respective International Federations.
2. Whether FISU foresees any framework, conditions or scenarios under which the participation of athletes from these countries at Changchun 2027 could differ from the general framework adopted on 26 May 2026.
3. How FISU intends to address the situation of member federations whose national legislation prohibits joint participation with athletes from the Russian Federation and Belarus, so that the student-athletes of such countries are not effectively excluded from the Games through no fault of their own.

3. Request regarding entry deadlines

The legal situation in Latvia is currently the subject of active discussion at governmental and parliamentary level, and it cannot be excluded that the legal framework, or its application to specific events, may change before January 2027. For this reason, we respectfully ask:

- whether FISU and the Organising Committee would be prepared to grant LASS the possibility to **submit or confirm its quantitative and individual entries after the official entry deadlines** set out in the FISU regulations for Changchun 2027, by way of an exception justified by the circumstances described above; and
- if so, what would be the **latest possible date** by which entries from Latvia could still be accepted from an organisational and technical point of view (accreditation, accommodation, visas, transport).

We are aware that similar situations have been faced by other national federations, and we would be grateful if FISU could share its experience and any precedents in handling such cases.

4. Closing remarks

LASS deeply values its membership in the FISU family and the educational and sporting mission of the World University Games. Our greatest concern is that Latvian student-athletes, who bear no responsibility for this legal conflict, may lose the opportunity to compete at the most important event of their student careers. We therefore remain fully open to dialogue and would welcome the opportunity to discuss this matter with FISU representatives, including by videoconference, at your earliest convenience.

Thank you in advance for your understanding and cooperation. We look forward to your reply.
